Textual Information()

The Company had initiated buyback of its equity shares from 13th December, 2022, through stock market route. It was completed on 24th March, 2023. Total 1,76,078 equity shares were bought back, this has resulted into reduction in shareholding in the category of PUBLIC. The PROMOTERS shareholding (2098788 equity shares) has not changed, as they did not take part in the Buyback. The pre-buyback shareholding of Promoters i.e. 45.73% and of Public shareholding i.e. 54.27% has been changed post Buyback, as 47.56% and 52.44% respectively. The post Buyback paid-up capital stands at 44,13,300 equity shares as against the pre-buyback paid-up share capital of 45,89,378 equity shares of Rs.10/- paid-up. Kindly refer to our letter No. JPL/CS/1946/2023 dated 24.03.2023, submitted to the exchange, in this regard.
